#### Food Vendors

#### Rules and Regulations

Listed below are the rules and regulation that you are agreeing to accept by signing your application.

#### Dates and Times

Saturday September 4, 2010- 9:00 am – 5:00 pm

Sunday September 5, 2010- 9:00 am – 5:00 pm

#### Booth Space

- You are renting a location only. You are responsible for supplying your own tables, chairs and any other booth equipment or signage you may need.
- Booth size needed must be indicated on application.
- Vendors are required to dispose of their own waste products in the provided dumpster. Trash receptacles placed around the grounds are for the customers use and convenience. Cardboard boxes must be broken down and placed in dumpster. Any vendor's assigned space left in disarray or with loose trash may forfeit their participation in any future festivals.
- DO NOT dump grease or ash on festival grounds.
- Due to limited electrical outlets anyone needing electricity should be prepared to provide for themselves. If you have a gasoline generator that you will be using, please inform us.
- Water will be available near the rest room building.
- No security will be provided. Vendors are responsible for their booths and contents.
- A limited number of booths will be available. All spaces will be on a first come first serve basis. All booths must be self contained and independently operated.

#### Booth Fees

- Booth fee is \$125 and must be submitted with application.
- Limited number of electrical outlets is available at \$25 per outlet.
- Checks returned from the bank for any reason will void your show eligibility and you will incur all penalty fees.
- Booth fee is non-refundable once accepted.

### Rain Date Policy

- The festival goes on Rain or Shine. No Refunds.

### Set Up/Break Down

- Friday September 3 set up will begin at noon and continue until 7 pm. Parking will be available in the festival grounds. No parking will be allowed adjacent to booths.
- No vehicles will be allowed in the show area before closing.
- Set up and Break down times will be enforced.

### Vendor Conduct

- Although you may, or may not be from this area you are a representative of the local area. Since our customers are traveling tourist, it is important that we leave a good impressions with them. Therefore any discourteous acts or inappropriate acts will not be tolerated.
- Show directors reserve the right to remove any vendor violating the guidelines.

### Taxes

- Each vendor is responsible to collect and report NC sales tax. Remit to: Sales & Use tax Division, NC Department of Revenue, PO Box 25000, Raleigh, NC 27640

### Pets

- No vendor's pets allowed in booth during show hours.

### General Rules

- Overnight camping onsite is not allowed.
- Show sponsors reserve the right to deny any application without explanation.
- Neither TR Beck, show sponsors, nor the Town of Maggie Valley will be held responsible for any damage to the property or persons participating in the show.
- All Food Vendors are to follow all federal, state and local food handling regulations and are to deal directly with all appropriate agencies.
